CONSTITUTION

ARTICLE I: NAME

The name of the club shall be the Kent County Aeromodelers, Inc., Dover, DE 19901.

ARTICLE II: PURPOSE

The Kent County Aeromodelers, Inc., is a club formed for the purpose of "Fly for Fun". It is a non-profit organization, which falls under IRS Tax Code 501(c)(7), chartered by the Academy of Model Aeronautics (AMA). The primary objective of the club is to foster and promote the design, construction and flying of radio-controlled model aircraft. It is also the objective of the club to promote flying improvement by each member.

ARTICLE III: MEMBERSHIP

1. All members of the Kent County Aeromodelers, Inc., both present and prospective, shall be subject to screening for continuance or acceptance in the club by the Board of Directors.
2. Any radio-controlled model aircraft enthusiast, after meeting the requirements of this article, may be admitted into membership.
3. The club is open to all applicants. There shall be the following categories of membership
 - a. **Open (Regular) Member** - Any individual at the age of 19 as of July 1st or older who presents himself/herself for membership with appropriate AMA membership and who is accepted for membership by the Club.
 - b. **Associate Member** - The spouse of an Open member who may participate in all activities of the Club. The Associate member must possess a separate AMA membership in order to participate in flying activities. Associate members are not required to pay KCAM club annual dues.
 - c. **Junior Member** - An individual that is younger than 19 years of age as of July 1st. A junior member shall hold AMA membership in order to participate in flying activities.

- d. **Honorary Member** - Any individual who, in the judgment of the Board of Directors and confirmed by 2/3 of those in attendance at a regular meeting at which such candidate is presented, deserves such distinction and he/she maintains a valid AMA membership. Honorary members are not required to pay KCAM club annual dues.
4. All flying members regardless of category shall maintain a valid and current "AMA membership, and FCC license where required by law".
5. All members that pay dues, or are exempt from paying dues, are eligible to vote and hold office. A junior member automatically becomes an Open member upon becoming 19 years of age as of July 1st.
6. A candidate for Junior membership must be sponsored by an Open member.
